Question 1 [12 marks]. You are assigned the task of studying whether COVID-19 mitigation measures, including the 'lockdown', may have unintended health consequences. It was decided that the use of alcohol, cigarettes and e-cigarettes would be compared before and after the lockdown.
(a) Explain what sources of data you might use for this study.
(b) Explain what form of data analysis this study is (i.e. descriptive, inferential or predictive).
(c) Explain what cross-sectional and what longitudinal data is relevant to this study.
(d) Explain what data visualisations might be used in this study.

Question 2 [9 marks]. Suppose three tests are administered to a random sample of college students. Let $\hat{X}$ be a $n \times 3$ matrix, where the score of the $i$ th students on the $j$ th test is $(\hat{X})_{i, j}$. Suppose that the sample covariance matrix of $\hat{X}$ is

$$
S=\left(\begin{array}{lll}
5 & 2 & 0 \\
2 & 6 & 2 \\
0 & 2 & 7
\end{array}\right)
$$

The eigenvalues of $S$ are 3,6 , and 9 .
(a) Find the component corresponding to the eigenvalue 9 .
(b) There are components corresponding to each of the eigenvalues. Which of them would you say are principal? Explain your reasoning.

Question 3 [16 marks]. Two interviewers ranked 15 candidates (A through O) for a position. The results from most preferred to least preferred are:

## Interviewer1 : ABCDEFGHIJKLMNO

> Interviewer2 : CABDFEHGJILKONM

The rankings of the candidates by the two interviewers were therefore

(a) (i) Compute the Spearman correlation coefficient $r_{s}$ between the two rankings.
(ii) For a $t$-distribution approximation involving $r_{s}$, find the $p$-value of the $t$-statistic and use it to decide whether or not the rankings are correlated.
(b) Compute the Kendall correlation coefficient between the two rankings.

Question 4 [18 marks]. Let $Y$ denote the proportion of allotted time that a randomly selected student spends working on a certain aptitude test. Suppose that $Y$ is $\operatorname{Beta}(\theta, 1)$ distributed, where $\theta>0$. A random sample of ten students yields the data

$$
0.92,0.79,0.90,0.65,0.86,0.47,0.73,0.97,0.94,0.77
$$

(a) Obtain the method of moments estimate of $\theta$ for this data.
(b) Obtain the maximum likelihood estimate of $\theta$ for this data.

Suppose that in addition to the random sample of ten students, you know that two other random students took less than $60 \%$ of their allotted time working on the aptitude test.
(c) Obtain the maximum likelihood estimate of $\theta$ for this data and comment on the difference between the maximum likelihood estimate of $\theta$ that you obtain and the maximum likelihood estimate of $\theta$ that you obtained in part (b).

Question 5 [12 marks]. Let $Y_{1} \sim \operatorname{Exponential}(\alpha), Y_{2} \sim \operatorname{Exponential}(2 \alpha)$ and $Y_{3} \sim \operatorname{Exponential}(4 \alpha)$ be independent, where $\alpha>0$ is a parameter.
(a) Determine a constant $C$ such that $C\left(Y_{1}+Y_{2}+Y_{3}\right)$ is unbiased for $1 / \alpha$
(b) Find the Mean Square Error of the unbiased estimator you found in part (a).

Question 6 [9 marks]. Suppose that $Y_{1}, Y_{2}, \ldots, Y_{10}$ are i.i.d. Geometric $(p)$ with common p.m.f.

$$
P(Y=y)=p(1-p)^{y}, \quad y=0,1,2, \ldots
$$

The prior distribution on $p$ is $\operatorname{Beta}(4,3)$.
(a) Given that the data $y_{1}, y_{2}, \ldots, y_{n}$ satisfy $\sum_{i=1}^{10} y_{i}=42$, find the posterior distribution.
(b) Find the Bayesian estimate of $p$ under squared error loss.

Question 7 [9 marks]. The table below shows aggregate annual claim statistics for four different products over a period of five years. Annual aggregate claims for product $i$ in year $j$ are denoted by $X_{i j}$.

| Product $(i)$ | $\overline{X_{i}}=\frac{1}{5} \sum_{j=1}^{5} X_{i j}$ | $\frac{1}{4} \sum_{j=1}^{5}\left(X_{i j}-\overline{X_{i}}\right)^{2}$ |
| :---: | :---: | :---: |
| 1 | 125 | 130 |
| 2 | 85 | 60 |
| 3 | 140 | 35 |
| 4 | 175 | 100 |

(a) Calculate the credibility premium of each product under the assumptions of EBCT Model 1.
(b) Find the credibility estimate of the amount per claim for the coming year for product 3.

Question 8 [ 15 marks]. A small insurer wishes to model its number of claims for motor insurance using a simple generalised linear model based on the two factors:

$$
\begin{gathered}
Y O_{i}= \begin{cases}i=1 & \text { for 'young' drivers; } \\
i=0 & \text { for 'old' drivers; }\end{cases} \\
F M S_{j}= \begin{cases}j=2 & \text { for 'fast' cars; } \\
j=1 & \text { for 'medium' cars; } \\
j=0 & \text { for 'slow' cars; }\end{cases}
\end{gathered}
$$

The data is the 6 aggregate claim costs for each combination of factors.
The insurer is considering three possible models for the linear predictor:

> Model 1: YO

Model 2: $\quad Y O+F M S$
The Poisson distribution is used with its canonical link.
(a) Write each of these models in parameterised form, stating how many non-zero parameter values are present in each model.
(b) The table below shows the student's calculated values of the scaled deviance for these two models and the constant model. The degrees of freedom is defined to be the amount of data minus the number of non-zero parameters fitted.

| Model | Scaled Deviance | Degrees of Freedom |
| :--- | :--- | :--- |
| 1 | 40 | 5 |
| $Y O$ | 30 |  |
| $Y O+$ FMS | 23 |  |

Complete the table by filling in the missing entries in the degrees of freedom column and carry out the $\chi^{2}$ tests and calculations of change in AIC to determine which model would be the most appropriate. When applying a $\chi^{2}$ test, use significance level 5\%.
