

- The exploration of a research question that arises from a detailed understanding of **existing scholarly literature** (or lack thereof).

- Ability to think critically.
- A contribution to a field of research.
- Ability to conduct an **independent** research project.

# Activity 1: Dissertation structure and marking criteria

#### Dissertation structure and marking criteria

Go on to QM Plus and find the 'dissertation assessment guide and criteria'

Take 5 mins to read through the dissertation assessment guide and criteria on your own.

Then get into pairs (with a fellow PG or UG colleague) and take 15 mins to work through the following questions

- **1. Abstract**: At what stage in the dissertation are you able to write your abstract?
- 2. Background to Issue, Rationale and Objectives: Where does a research aim come from?
- **3. Methodology and methods:** What is the difference between your methodology and method?
- **4. Findings and results:** What things should help to structure your presentation of findings?
- 5. Analysis, Discussion, Conclusion and Recommendations: How does your analysis, discussion, conclusion and recommendations chapter differ from your findings and results?



#### **Abstract**

The abstract is a concise summary of your dissertation, usually about 300-500 words long. You should write it at the very end, when you have completed the rest of the dissertation.

In the abstract, make sure to:

- State the main topic, aims and objectives of your research
- Describe the methods you used
- Summarise the main results
- State your conclusions

## Background to Issue, Rationale and Objectives

- Establish you research topic and present the issue to be researched
- What is the background and context of the research?
- Why is this topic or issue important and for whom?
- Discuss the state of existing research on the topic and the relevance of your work to a broader problem and/or debates (embedded literature review):
  - How does your research fit into the bigger picture?
  - What are the key debates?
  - What theories and concepts are used to explain and unpack the topic?
- Based on the above craft a research aim, research question and research objectives.
- Briefly indicate how you will answer your question (methodology, methods and theoretical frameworks)



#### 1. WHY?

- Describe the methodology/theory of research that underpins the research
- **REALLY IMPORTANT!** Why is this approach the best to answer your research question?

#### 2. HOW?

- Method(s) of data collection
- Details of where, when or with whom the research took place
- Method of analysis

## Findings and results

- Once you have collected your data you need to present it and show:
  - The characteristics of your findings
  - Key themes
- Must be organised in a logical manner
  - Headings and sub-headings
- Descriptive, rather than analytical
- Provides 'stuff' that you can then work on further in the next chapter...
- The structure and feel of your findings section will depend on the type of study you are undertaking

### Analysis & Discussion

- Remind the reader of the aims, research question and objectives.
- Answer your research question.
- Discuss if the research findings fit with/can be explained by the theoretical frameworks you introduced in the background section.
- Discuss if there are further theories and frameworks that help to explain the results.
- If any of the results were unexpected, offer explanations for why this might be.
- Are there alternative interpretations of your data?
- Discuss any limitations that might have influenced the results.

## Conclusion and Recommendations or "SO WHAT?"

- What are the implications of your findings for relevant audiences (policy makers, other scholars, the public etc.)
- How have your findings contributed to knowledge in the field of global health?
- Have you identified any limitations of the research, or avenues for further research?








