Title...

- Try to include subject and study design in the title
- Make it concise and punchy
 - E.g., "A narrative review on barriers to and facilitators of health systems strengthening in East Africa"
- TIP: Good practice is to think what keywords/search terms someone would use to find your study and construct the title around these

...and abstract

- The abstract is a summary of everything in the proposal a sentence or two on each element
- TIP: Write the abstract at the end!

Introduction and background/rationale

- What is the problem you are addressing? Why does it matter?
- Drawing on key literature on your topic (use annotated bibliography if MSc) identify what's already been done, what gaps are, what methods, theories, and frameworks have been used
- Situate your own approach in relation to the above
- TIP: Remember here to synthesise across sources and end the section by clearly leading into your aims, question and objectives section.

Research aims, question and objectives Aim: What do you hope to achieve?

Research question: What question is your research answering, in order to achieve your aim?

Objectives: What steps will you take to answer your question?

Methods

- What is your chosen method (e.g., narrative review, policy analysis, indepth interviews) and how will this help you answer your question?
- Why is this the most appropriate method?
- Draw on methodological literature (**TIP:** Use further reading lists)
- Are there any ethical issues and do you need ethical approval?



Approach to analysis

- What theoretical perspective are you approaching your topic from?
- What frameworks will you use?
- Why is this the most appropriate approach to answering your question?
- **TIP:** This is early days in your project so you might not be sure yet, BUT for the purpose of this assessment, be **as specific** as you can we just need to see that you are thinking about theory and/or frameworks and how to apply them.
- TIP 2: You might need to look to non-topic specific literature to help you here. E.g., if you are taking an intersectional approach, find literature on intersectionality.

Expected contribution of your proposed research (MSc only)

- Who cares?
- Who will this benefit?
- How will it benefit them
- Be realistic here
- **TIP:** Be very specific and concrete, e.g., is there a specific organisation you are working with or might reach out to to share your research?

Timelines

- Use a Gantt chart to plan your research timeline
- This will help us (and you) to assess feasibility
- Use it as a guide to see if you are staying on track
- Gantt chart templates available under 'Assessment information' tab on QMPlus
- **TIP:** Term 2 is very busy up until you finish assessments, and the bulk of your data collection will happen after April don't overpromise here!

Reference list and referencing

- Use either Harvard in-text referencing (author, date) [or (author, date: page number) if quoting directly]...
- ...or Vancouver (numbered endnotes)
- Your reference list should be consistently formatted
- Using referencing software (EndNote, Zotero, Mendeley) will make your life easier down the line, but requires a bit of upfront practice
- Guidance on how to use these on the library website
- If using software, do still double-check your references!

Key things to bear in mind

- Feasibility feasibility!
- Link rationale, aims, RQ, objectives, methods and approach to analysis (and tell a story with the proposal!)
- Read literature on methods and frameworks/analysis
- Think carefully about timeline
- Word count differences between MSc and iBSc (check you are looking at right guidance)!
- Your project will change you are not locking yourself into anything at this point







Getting started: What you know and what you need to do

Getting started with planning and writing

- You should now have some understanding of your topic and relevant literature
- Today we will work on the following sections of your research proposal:
 - Intro and background/rationale
 - Methods
- The process we use here can be used for other sections









Get writing!

- Thinking and writing are connected
- Writing forces you to put down on paper what you know already
- Helps you identify gaps and what you need to do to address them
- Writing does not have to be perfect first time around
- But you do need to start somewhere

Introduction and background/rationale

- What is the problem you are addressing? Why does it matter?
- Drawing on key literature on your topic (use annotated bibliography if MSc) identify what's already been done, what gaps are, what methods, theories, and frameworks have been used
- Situate your own approach in relation to the above
- TIP: Remember here to synthesise across sources and end the section by clearly leading into your aims, question and objectives section.

The Task

- Pick a new person to work with
- Referencing the requirement for each section you have 5 mins to write down:
 - Information you know already
 - Gaps in your knowledge/things you're stuck on
 - What you need to do to come un-stuck

You then have 5 mins each:

- Explain what you have written down to your partner and how you plan to come un-stuck
- Your partner to give feedback on your proposed next steps — do they make sense, any alternative approaches, suggested forms of support? Etc.



Methods

- What is your chosen method (e.g., narrative review, policy analysis, indepth interviews) and how will this help you answer your question?
- Why is this the most appropriate method?
- Draw on methodological literature (**TIP:** Use further reading lists)
- Are there any ethical issues and do you need ethical approval?

Dissertation topic survey

- I. Student number NOT username
- 2. Your name
- 3. Draft dissertation title
- 4. I 50 words summarising drafts of your topic, aim, research question, proposed method
- 5. Any members of staff you have spoken to about your dissertation who you would like to supervise you



First supervisor meeting (iBSc)

- Discuss ideas and make a plan for the next month
- Next steps you need to take to complete proposal, e.g. refining research question, more reading, reflecting on feasibility
- Discuss whether you need ethics and if so, set a deadline together for a draft application (hard deadline is 19th of February for iBSc)
- Complete your dissertation supervisor agreement
- You need to have a date scheduled for your first supervisor meeting by 9th of December at the latest

 try to schedule it before the break, and to give you time to get their input on your proposal!



First supervisor meeting (MSc)

- Discuss your ARMI assessment feedback
- Discuss next steps you need to take, e.g. refining research question, more reading, reflecting on feasibility
- Complete your dissertation supervisor agreement
- You need to have reached out to your supervisor by Friday the 24th of January at the latest
