### 1) Content Description

This module will explore the human cardiovascular and respiratory systems; normal physiology and abnormal physiology (pathophysiology) will be covered. Students will be introduced to a variety of pathologies to facilitate a better understanding of how these systems are impacted by disease. The module will also integrate cardiorespiratory knowledge by considering cardiorespiratory adaptations to exercise and examining cardiorespiratory responses to different environments.

### 2) Module Aims

The aim of this module is to provide a physiological complement to a previous anatomy module. The module examines the initiation of the heart, the pumping of the heart, the circulation and the regulation of these, together with the processes of ventilation and gas exchange and transport. In considering these processes, the module examines abnormalities of function such as conduction and valvular failure, response to haemorrhage and hypoxia. It includes essential cardiovascular and respiratory calculations. The final section of the module aims to examine integrated cardiovascular/respiratory responses to exercise.
