 - This version prior to peer-review does not contain any value when funders' Open Access publishing mandates are concerned, but they can be deposited in pre-print servers or repositories (e.g. arXiv)

 - This peer-reviewed version, minus publisher formatting, can be self-archived in institutional or subject repositories to comply with funders' Open Access mandates (Green route)

 - This is the version of the paper with publisher formatting and illustrations, tables, etc. added if applicable

 - This is the version of the paper with publisher formatting and illustrations, tables, etc. added if applicable
 - This published version can be made open access to everyone immediately to comply with funders' Open Access mandates if an Article Processing Charge has been paid (Gold route)

 - The author must retain copyright and there must be a [CC BY Licence](#) attached to the paper

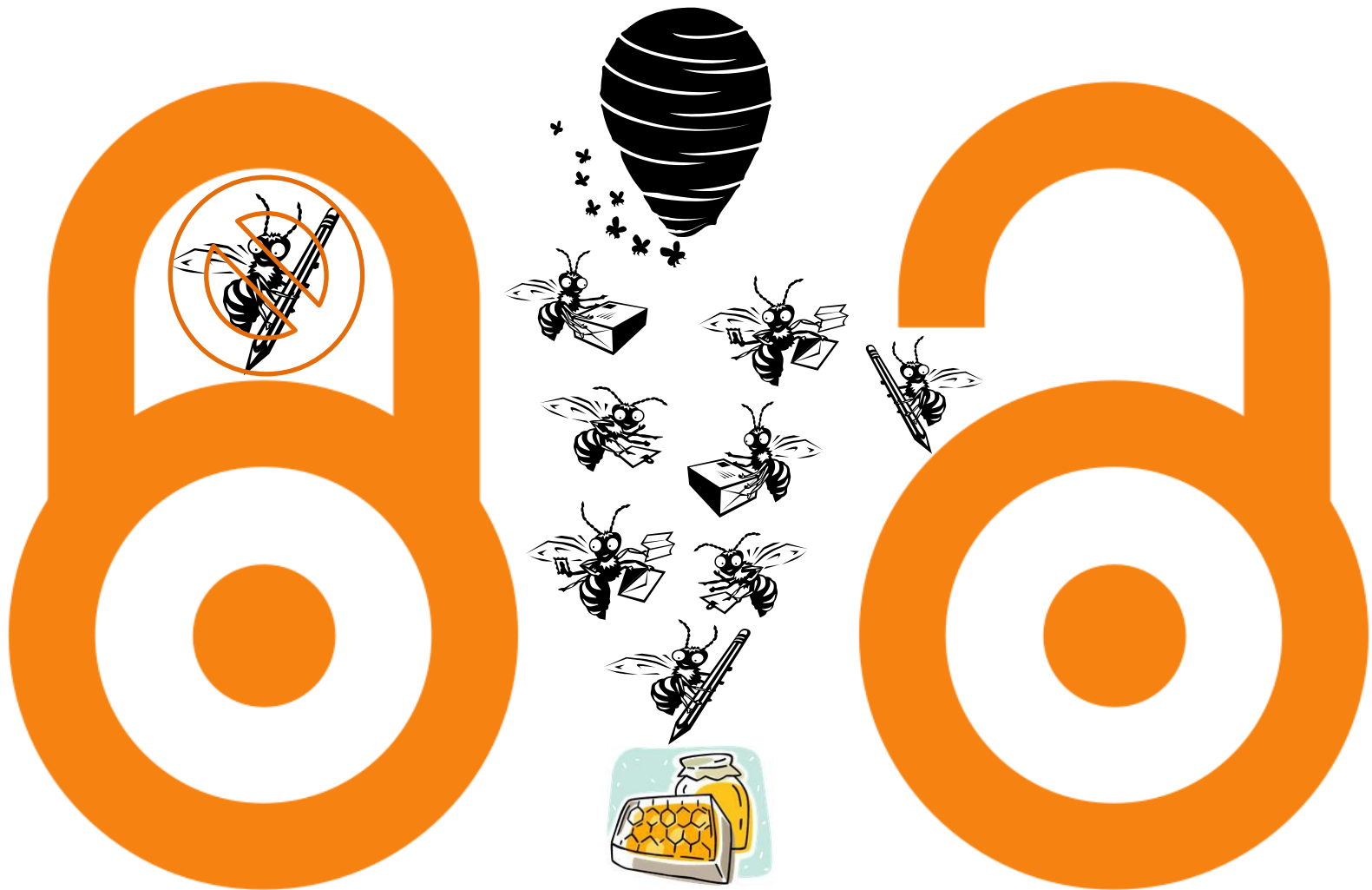
