Module title: Haunted: Literature of Ghosts, Spectres, Apparitions

Content Description

This module reads stories of hauntings, both literal and figurative. We will explore the complex meanings of literary ghosts, spectres, and apparitions in a range of short stories and novels. Through our readings of ghostly figures, we will study literary experiments with lingering traces of the past, unseen truths in the present, and looming fears about the future. Topics under consideration may include: conceptions of time; modernity and its fragments; repressed, violent, and forgotten histories; strangeness and unbelonging. You will gain familiarity with key works of non-Western fiction; literary techniques of modernism and surrealism; and theories of the uncanny, the alienated, and the marginal.

Module Aims

- 1. introduce students to haunting as a literary technique and representational strategy in a range of culturally and linguistically diverse texts;
- 2. introduce students to key novels and short stories from non-Western (and particularly Asian) literary traditions, and practice cross-cultural literary comparison;
- 3. develop active reading skills, including close reading and other methods such as reading for structures, for silences, for contradictions, for history, social difference, culture and language;
- 4. explore and develop a critical position on various theoretical approaches (including psychoanalysis, temporality, fragmentation, postcolonialism, alienation, modernism, surrealism);
- 5. develop students' critical self-reflexivity about their own ideas and socio-political positions while reflecting on and analyzing texts that may be from a context different from their own.
