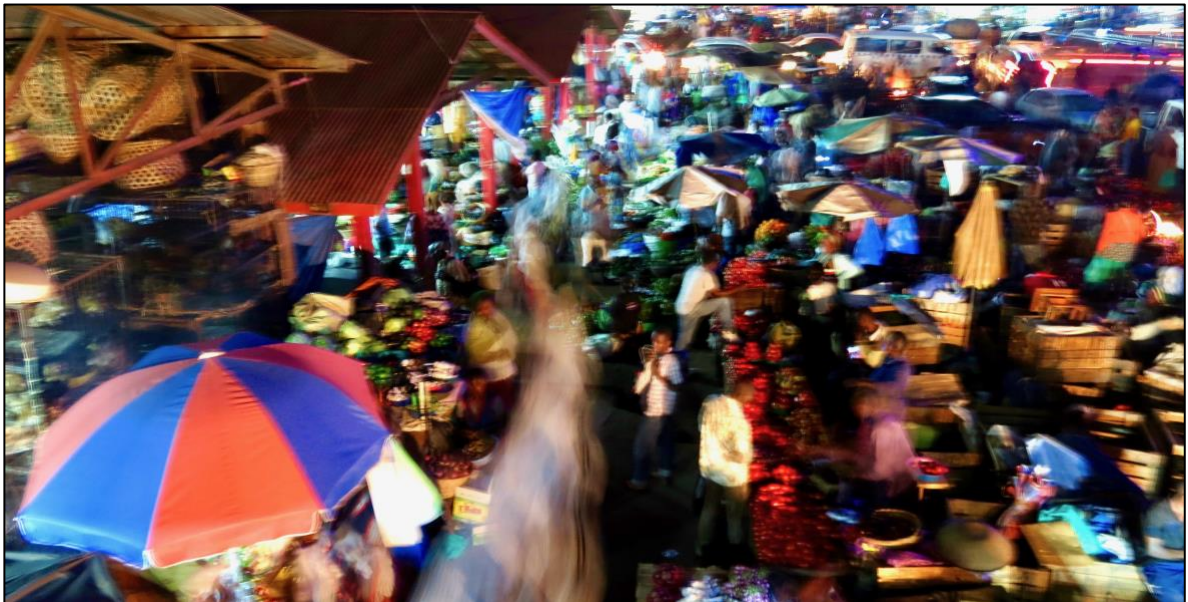

URBAN AFRICAN ECONOMIES

AIMS AND OBJECTIVES

Conventional social science has tended to downplay the creativity of urban African societies and economies as well as their 'capacity to produce metaphors for their own possible futures' (Sarr 2020). Combining approaches from urban, economic and development geography, this module provides students with a critical and historically grounded understanding of urban African economies. It revitalises debates on work, value and exchange through an engagement with local expressions of informality, hustle and solidarity entrepreneurship.

Drawing upon insights from academia, policy, film and the media, the module explores the following questions:

- What are the historical drivers of urbanisation and urban economy in Africa?
- What are the key challenges for African urban economies today?
- How are these challenges represented, understood and experienced by different groups?
- What insights might African cities provide for thinking 'the economy' differently?

LEARNING OUTCOMES

Students will be expected to actively participate in lectures and seminars through written input, group discussions, and verbal presentations. In return, they will learn about key debates and trends relating to urban economies in Africa. In particular, students will acquire and develop:

1. An ability to analyse and critique conventional representations of African cities
2. An understanding of the ways in which African cities have been shaped by global and historical processes
3. An awareness of relationships between local, national and international actors and institutions, and their influence on urban development processes
4. Interpretive skills, demonstrated through the appropriate application of concepts to particular situations
5. Comparative skills, demonstrated through the appropriate comparison of different contexts
6. Writing skills, demonstrated through the arguments and syntheses of information for academic and non-academic audiences

ASSESSMENT

The module will be assessed as follows:

- Coursework (100%) You will complete a coursework assignment of 3,000 words responding to one of several questions raised in the lectures. The coursework questions will be released in advance of Reading Week.
