



4 rotations

- 4 groups of logbooks, Paper A
 - must pass all to pass the year
 - failure of one/two remediation possible if time allows
 - failure of three barred as a minimum
 - failure of all four re-sit year/deregistration
 - remediation possible over Xmas, Easter, Summer with deferment
 - Module leads will determine level of remediation required

- 4 rotations
 - 4 groups of logbooks, Paper A
 - must pass all to pass the year
 - Will be barred for failing 3 logbooks even if remediated
 - remediation possible over Xmas, Easter, Summer with deferment
 - no remediation, cannot progress to year 5

barring

 failing logbook assessments in 3 or more clinical rotations

- barred from main end of year exams
 - sit late summer as 2nd sit
 - re-sit year as 2nd sit
 - If already on 2nd sit then 3rd sit
 - If already on 3rd sit then deregistration

Blueprinting end of year

- so that the proportion of questions in the exam is roughly the proportion of delivery time in the year for each subject
- all three papers considered equivalent
- module leads commissioned to provide questions
- style and proofing
- external review

Papers B & C

- Paper B
 - SBA paper of 2 hours (max 120 questions)
- Paper C
 - multiformat SBA, calculation, etc
 - 2 hours
 - Max 120 questions written around data and scenarios
 - radiology
 - clinical images
 - lab result tables
- Will be delivered invigilated on campus

Passmark - Angoff

- panel of faculty
- review each item
- "what proportion of borderline students should get the question correct at the level of an FY1 on day 1"
- mean for each item from all of panel
- mean for the exam = pass mark

OSCE

- Objective
- Structured
- Clinical
- Examination

The exam is objective, examiners use their subjective knowledge to score each candidate = experienced judgement

OSCE

- Up to 3 days
- 10.5 min inc 1 min prep time
- Final format of OSCE yet to be determined
 - Total stations likely to be 12
 - All stations have 1 min of prep time included
 - 25% extra given if you have EAAs
- all candidates take one circuit over the course of each day

OSCE Feedback

You receive a score

There is a global rating score

There are boxes for written feedback

You will get feedback after results

OSCE Global Score


 The global rating is the overall judgement from the examiner of your performance in the station

It does not determine if you pass or fail a station

 It used to set the pass mark and is feedback for you

How do we set the passmark for the OSCE

Borderline Regression Method



Done in Excel for each station

OSCE Mark

- Your score from each station is added to give a final OSCE score
- The passing score for each station is added to give the OSCE passing score
- You must achieve this passing score to pass the OSCE, and
- Pass more than 60% of station, ie on a 12 station OSCE you must pass 8 stations


No longer takes place in the OSCE

Pre-covid we did not do this for student welfare

• Fair or unfair?

 Looked at the stats and found that it made no difference if you were placed in AM or PM session if you weren't held.

- This comes from data we have in year 5 for over 10 years...

2021 Passmarks 2022 Passmarks

- Paper B = 57.92%
 - Fail rate = 6.2% at first sit
- Paper B = 58.55%
 - Fail rate = 15.4% at first sit

- Paper C = 57.26%
 - Fail rate = 11.5% at first sit
- Paper C = 59.12%
 - Fail rate = 10.2% at first sit

- Paper D = 51.13%
 - Fail rate = 1.6% at first sit
- Paper D = 53.08%
 - Fail rate = 4.2% at first sit

2022 Passmarks 2023 Passmarks

- Paper B = 58.55%
 - Fail rate = 15.4% at first sit
- Paper B = 53.26%
 - Fail rate = 1.3% at first sit

- Paper C = 59.12%
 - Fail rate = 10.2% at first sit
- Paper C = 58.41%
 - Fail rate = 5.0% at first sit

- Paper D = 53.08%
 - Fail rate = 4.2% at first sit
- Paper D = 65.86%
 - Fail rate = 4.7% at first sit

After 2nd sit...

95.6% pass rate

4.7% higher than previous year

We simply adjust the passmark back to 50%

 We used a crude method to do this previously but this year it will change... no UKFPO ranking

- All the exams you take don't have a passmark of 50% on the raw score
- We simply adjust the passmark back to 50%
- Your raw score (R) is then adjusted to account for the set standard (P) and the pass mark of 50% for the course:

=IF(R>P,R*50/P,(R-P)*50/(100-P)+50)

MySIS can only have one set passmark for an exam which needs to be entered before the year starts therefore we say 50%.

 Exact dates will be provided 8 weeks before (22nd April 2024)

fit to sit & ECs

- taking the exam, declares fitness and renders irrelevant subsequent EC claims
- ECs extraordinary unpredictable events in the immediate run up to exams
 - fill the in form on MySIS
 - supply the evidence (not necessary but helps)
 - Allows deferral of sit not progression

disability and SpLD

- apply for any examination access arrangements in advance
- through Disability & Dyslexia Service
- Seek advice from Student Academic and Pastoral Support
- Student Support Card...

subject exam board

- meets ASAP after the last exam
- 3rd July, results 9th July
- ECs and Cause for Concern forms
- reports, complaints, offences
- statistical reports
- results

Distinctions & Merits

Cohort ranked on average scores from Papers
B, C, D and E (equal weighting to all)

- Top 10% awarded a distinction
- Next 15% awarded a merit

the unsuccessful few

little time for remediation

major failure could mean a repeat of year, ie
2 or more papers failed

the unsuccessful few

- re-sit intended to compensate for ECs
 - Aug 12-15th, result Aug 22nd
- Year 5 starts 27th Aug
- fail on second sit deregistration?
 - Working on implementing standard automatic third sits
 - But... after third sit it will mean automatic deregistration
 - Third sit would always take place during a repeat year
- appeal mechanism
